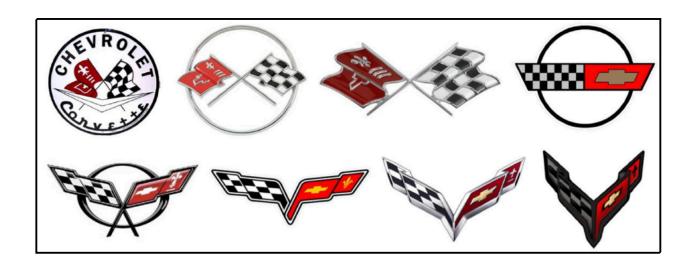

Before talking about NCM news, Don mentioned a special event on May 31 at Kevin Harvick's Kern Raceway featuring a race between Kevin and son Keelan. Corvettes of Bakersfield has arranged a special program for the event. Don will share the flyer with SLO Vettes (See page 33). For those who sign up, the COB program will include a preevent lunch, a caravan to the Raceway, a Corvette cruise-in and show, a Corvettes parade lap on the track, dedicated parking, free admission to the race, special seating for the race, and pit access. Meet-up locations are being arranged for SLO Vettes participants at a donut shop in Paso Robles and at Highway 58. SLO Vettes participants can look forward to a drive over backroads to Bakersfield. This COB event is also a fund-raiser for the charitable organization Portrait of a Warrior.

Don reported on the recent CEO changeovers, with the most recent one leaving after less than a month. He thought new Board of Directors member Ken Lingenfelter would be a good addition. There is no information yet about the new Corvette model. A question for consideration: Would it benefit Corvette to be its own brand? It now competes on the world stage, so it may need to upgrade the buyer's experience to that offered by Porche, Ferrari, and similar high-performance brands. A California State Senate bill, termed "Leno's Law," is being spearheaded by Jay Leno. It would exempt classic cars 35 years or older from the state's smog check program. # National Corvette Museum Update

Current C8 owners will probably notice the "wall of buttons" (a/c controls) is missing and the info screen is twice the size of the usual C8 screen. These features that were caught by a spy photographer of a test mule in Michigan. Current C8 owners and shoppers either have little regard for or hate the wall of buttons. I am hoping GM will reveal this change for 2026 models at the NCM Bash

April 24-26, 2025. By the time this issue of the newsletter is published maybe I will have some real news to report on any changes.

## New CEO Appointed and then Resigned. Another New CEO Appointed.



David Hill was was recently appointed the new NCM President and Chief Executive Officer. While initial expectations were high, Mr. Hill was carrying some baggage that went undetected during the hiring process.

Hill is a lifelong Corvette enthusiast with extensive leadership experience. While the last couple of CEOs have come with extensive museum, philanthropic, and non-profit experience, Hill comes with a more private-sector corporate background. The really good news was that Hill was already a Corvette enthusiast. He has restored a 71 Stingray and a 67 Coupe.

Now for the rest of the story from Keith Cornett at Corvetteblogger.

The National Corvette Museum's new CEO David Hill just started his new position last month, but now there are questions about how customers and employees of his classic trucks' restoration parts company were handled after the company was abruptly shut down last month.

Mar-K was the name of the classic truck parts company that was based in Oklahoma City and it offered sheet metal products which were used in restoring pick up beds. A video shared on Facebook says the company was very well-regarded among Chevrolet, Ford, and Dodge enthusiasts who turned to the company for complete bed kits, tailgates, bed wood, body moldings, and more. Originally founded in the 1970s, Mar-K was taken over in 2016 by David Hill.

Keith reported, "We're not exactly sure for the reasons that Mar-K suddenly closed, but we were sent a link to a Facebook group that focuses on 1947-1955 Chevy Trucks. A member of the group posted on April 2nd that "Apparently Mar-K is no longer in business. Anyone know why?" The post had over 90 comments with some saying they have paid thousands in advance for parts that no longer appear to be coming."

In addition to these individual customers, larger corporate customers like after-market car parts giant, Summit Equipment, also appear to have been left hanging after the closure.

Keith summed it up pretty well in his comments:

I can't even imagine the feedback if it were Corvette owners that were getting blindsided with a business closing while still being owed parts, and the last place we would want to see the owner of that company is at the head of our National Corvette Museum. David either needs to comment publicly about the closure of Mar-K, or the NCM Board needs to make a change immediately.

This is obviously very disappointing, and it's the third strike for those on the NCM Board who have utilized the same headhunting firm that brought us Dr. Sean Preston and Sharon Brawner, both who were fired by the NCM Board during their second year in the position. As news broke over the weekend, we had several friends who are lifetime members of the NCM saying they are done providing donations unless or until they get things straightened out in Bowling Green.

Well, it appears that the NCM took the Corvetteblogger seriously and on April 9, 2025, the NCM sent this out to its members:

"Effective immediately, David Hill has submitted his resignation as President and CEO of the National Corvette Museum, which has been accepted by the Board of Directors. We thank him for his time with the organization and wish him well in his future endeavors.



We are proud to share that Bryce Burklow has been appointed President and Chief Executive Officer, effective immediately. A dedicated 15-year veteran of the Museum, Bryce has served in key leadership roles across Events, Facilities, and most recently as Interim Chief Operating Officer. His deep understanding of our operations and passion for the Corvette community position him to lead the Museum forward with strength and purpose.

We appreciate your patience and understanding during this transition. The high level of interest and engagement from our Members and the Corvette community has been a powerful reminder of how much this institution means to so many. Thank you for your continued support as we drive into our next chapter."

Hopefully, Bryce will prove to be the right choice to bring some stabilization to the organization. His first order of business should be to terminate any remaining contract the NCM has with the head-hunting firm and start doing their own recruiting complete with a more comprehensive background check.

The Museum has been undergoing several personnel changes over the last few years and now many of the management team are new. Hopefully this appointment will bring some stabilization to the organization.

Whether you walk, jog, run, bike, or skate, this is a place where you can enjoy your favorite forms of fitness in a safe environment."

The track features a variety of elevations changes, offering a dynamic surface to exercise. There are several configurations allowing guests to customize the length of

their workout. Pets are welcome at the facility if they are on a leash, and owners must clean up after their animals. Roller blades and roller skates are also welcome; however, skateboarders are asked to use the skatepark downtown instead. Helmets are required. No motorized vehicles are allowed on the track during this activity. In the paddock, a large flat, paved surface is available for anyone doing speedy work.

# **Assembly Plant Update**

# Chevrolet to Launch a Build Your Own High Wing Experience for Z06 and ZR1 Buyers

Remember the "Build Your Own Engine" option that GM offered to C7 Z06 and ZR1 buyers? For an additional price, purchasers of those C7 models could travel to the Assembly Plant and actually assemble their own engine. Not without supervision of course. Buyers would work under the watchful eyes of a GM worker in the Performance Engine Build Center located in the Assembly Plant. The option has yet to be offered to C8 buyers.





Buyers of C8 Z06 and ZR1 models are soon to get a somewhat similar perk but I view it more as a guarantee rather than an exhilarating experience. Many of past Z06 and ZR1 customers have tried to order their cars with the High-Wing Option only to be told that option was on constraint and not available. Imagine buying one of these cars without being allowed to include probably the most obvious visible upgrade to the exterior. There are lots of Corvettes out there but few with the High Wing Option. As you can see in the photos above, this feature jumps out and screams performance not to mention that they are integral to the performance and stability of the cars at high speed.

GM has come up with a new plan that will guarantee buyers of the high performance ZR1 and Z06 Corvettes can get the large wing. Chevrolet is introducing a new Build Your High Wing Experience that will allow buyers to participate in making their own High Wings for their soon-to-be produced Corvettes. The process will begin soon and takes about eight hours as participants get hand-on experience working with composite materials at the Corvette Assembly Plant's new Composite Build Center which was just completed during the plant's two-week shutdown in late March.

GM refused the demands and ultimately the trucking firm went under.

Corvettes still need to be transported and evidently the new contract has come with some sort of an increase. The \$200 increase came as an adjustment to the destination freight charge you see on the window sticker. ### Leno's Law

Comedian Jay Leno is throwing his weight behind a California proposal that would exempt classic cars at least 35 years old from smog-check laws. The current law exempts 1975 and older cars, but State Sen. Shannon Grove's plan would apply to 1990 and older cars that aren't used for regular transportation. Thanks to the prolific car collector's support, Grove has dubbed it Leno's Law.

Anyone with a C3 or pre-1991 C4 Corvette should benefit from the law change, especially so if they are having a hard time finding smog equipment/replacement parts to ensure their cars can pass smog every other year.

#### Should Corvette Be Its Own Brand?

I happened across an article recently that opened my mind to an argument for GM to pull Corvette from Chevy and set it free as its own. With the development of the midengine design, GM has set its sights on the world stage and taken aim at the supercars coming from Ferrari, BMW, Mercedes, Aston Martin, and Audi just to name a few. Along with taking on the big names, GM remains committed to the fact that the car will be a part of the Bowtie brand.

You can't just compete against those pedigrees without considering the total package being offered to the customer. While I have no experience with those high-end brands, I can relate on a smaller scale. We own Toyota and Lexus cars and while we are happy with both, there is no comparison when visiting the dealership regardless whether we are there to buy or to have the cars serviced. It doesn't matter if your Lexus is old or new, Lexus offers creature comforts and personalized service that Toyota lacks. Luxurious waiting areas, upgraded snacks and coffee, free key fob batteries, free loaner cars, and pick-up and delivery services are a commonplace at Lexus. Not so at Toyota.

Say I want to buy an E-Ray (\$110,000 plus), Z06 (\$114,000 plus), or a ZR1 (\$175,000 plus). Of course, I have already did my research and compared Corvette to the competition and decided Corvette is the car for me. For that kind of money, I might expect some heightened level of experience when visiting the dealer.

There are some Corvette Z06 buyers who feel that Chevrolet dealers leave something to be desired from an ownership standpoint. Based on a report from Corvette Forum, there seems to be a consensus that owners want more out of their dealership experience. For instance, one user stated, "I recently purchased a 2025 C8 Z06 and I am learning that the ownership experience for a 'supercar' is no different than any other Chevrolet... It has had an oil leak (27 miles leaking oil onto my garage floor. technician could not locate oil leak), and has now been at the dealer for the week getting paint repaired due to an improperly fitted bumper." Another forum poster expressed similar frustrations, claiming that, "The vast majority of dealers aren't focused on Corvette buyers and the service departments don't even put in a modicum of effort to try and put your mind at ease."

Not every dealership is equipped to work on a Corvette. It takes special tools and service equipment. Corvette-certified technicians receive specialized training far above that provided to GM-certified techs. Hopefully the tech assigned to service your Corvette is properly trained.

From my personal experience, that is not always the case. A lot depends on the shop's workload. I now always ask if the tech is Corvette trained and if not, I ask if I can reschedule for a day where I can be guaranteed that he or she will be. Then I give the service writer my cell phone and ask him to call me when the car is done. I either walk to the Lexus dealer to sit in their waiting room or to the nearest Starbucks.

If Corvette were to stand alone, most all of us would be greatly inconvenienced by having to travel some distance to the dealer. Unlike today where there are multiple Chevy dealers to choose from, it might be like owning a Lexus in SLO when the closest dealers are in Monterey and Santa Barbara.

I vote for the Chevy dealers remodeling the waiting rooms, upgrading the refreshments, and brainstorming what services could be offered as perks to their customers. I for one, appreciate the pastries, Starbucks coffee machine and the soda fridge SLO Chevy makes available to us for our meetings.

# **GM** Goes to England for a New Corvette Concept Design

Recently I reported that longtime Corvette Exterior Designer Kirk Bennion was let go into a forced retirement. Now I see that General Motors has expanded its global design studio footprint with the official opening of a new advanced design studio in Royal Leamington Spa, about 20 miles from Birmingham. In connection with the opening, GM revealed an advanced design study Chevrolet Corvette concept car developed by the UK team as part of a global design project involving multiple studios that will see additional Corvette concepts revealed throughout 2025.

No internal combustion engine here. This design is all-electric.



Its sleek shape to its aero-intensive body has giant 22-inch front and 23-inch rear wheels. It even integrates a Formula 1-style halo roof structure with a spine that bisects the windshield, sort of the opposite of the '63 Split Window C3.

GM says the exterior design showcases a distinct division between the upper and lower

halves of the vehicle, with the upper half focusing on Corvette's classic design elements. The lower half, in contrast, focuses on integration of the EV battery. Trick aerodynamic features increase EV range and efficiency in some settings and increase downforce in others, including a sculpted underbody with fan assistance to suck the car to the road. Special active ducting redirects air over and through the vehicle.



Don't worry, it is not a C9. I do like the lines but I ask why go outside the U.S for design ideas for America's sports car? I also wonder why GM went electric-only when other high-end sports car designs/prototypes are moving back to gas power or hybrid gas/electric.



# Man Is Shocked When He Discovers Why His Car Is Making Weird Noises

Spring is a busy time for squirrels. They are building nests to prepare for having babies and searching out food to stash away for when they need it and keep it away from competitors.

One Michigan man recently discovered the squirrels in his neighborhood had been very busy using his car as a food bank.

Kellen Moore's engine had been making weird noises when he switched on the air conditioning so he went to take a look. He opened the hood of his car and discovered a squirrel (or squirrels) stashed more than 50 pounds of pine cones throughout his car engine!

Gabe Awrey snapped a picture of the squirrel's handiwork when Moore invited him to to take a look while they were at work. He shared the photo on Facebook along with the warning to car owners, "Remember to check your engine bays this time of year! The squirrels are sneaky. This was my friend's car today!"



"Literally every free space in that engine bay was FILLED," Awrey wrote on <u>Facebook</u>. "The heat from the engine opened all of these bad boys up too, making them lodged in some places."

They spent the next 45 minutes removing the sticky pine cones from the car's engine bay.

Moore joked afterwards that he would be "spending the night in my car, parked in the driveway tonight...I'm going to strangle that squirrel with my bare hands."

But in all seriousness, Awrey and Moore's advice is to check under your hood more frequently this time of year if you are in an area with lots of squirrels.

Awrey's post prompted others to share their squirrel misadventures.

Colleen Crannell commented on Facebook that squirrels favored her CRV and were continually building "nests under the hood, they were chewing up my wiring harness and other parts made w/eco friendly 'soy based parts'. Got rid of the CRV after the 3rd trip to shop, got a new Hyundai and 2 weeks after owning that this winter I came out one day to find it wouldn't start. Opened the hood and there was a HUGE nest and major chewing done all in one day!!"



David Rea had a similar experience to Moore and shared "Been there, done that." Been there, done that...this is ONE HALF of the pine cones... Ford dealer took out other half and put mothballs in engine compartment."

There are ways to discourage squirrels from using a vehicle as a secret stash hideaway. Rea mentioned using mothballs. But other ways including humane harassment, especially if you have a mother nesting. The <u>Toronto Wildlife Center</u> recommends the following:

- Place a bright light under the hood of the car. Tune a radio to a talk station and place it under the hood of the car (not music, human voices).
- Soak rags in apple cider vinegar or ammonia and put them in a plastic bag. Poke holes in the bag and hang it under the hood of your car. Dirty

kitty litter will also be effective.

- Do this for at least 3 days and 3 nights. That will allow the mother squirrel to move her babies and leave the nest.
- Trapping and relocating squirrels doesn't really work because they are territorial and usually results in the squirrels dying.

As for Moore's car? Thankfully, after Moore and Awrey removed all the cones, the car still runs just fine.

# Season 3 Episode 2: Keeping Your Cool





This article is in response to a discussion sparked by John Everett, one of our members who owns a 2005 C6 Corvette.

John wrote, "Russ, thought I might pass along a bit of info on my C6 radiator that I think folks should know about! I didn't! Seems the radiator is at an angle and behind a narrow passage that channels fresh air from under the car into the radiator opening. We'll, that fresh air also contains all sorts of debris, and that debris gets ingested into the fins. It's in a

pretty difficult place to access and clean out. I haven't done this yet, but my plan is to get the car up on a lift and use an air or water stream to flush out the debris. If you want to put this out to members, feel free, and any advice on this is welcomed."



John is correct about trash getting into that confined area and besides being difficult to clean, it is also difficult to see from just a glance into the engine bay. This item of maintenance is often overlooked because unless your Corvette is overheating or you learn about this from someone, most never think to inspect the area.

The photo in the header of this article is an example of what you might find in your C4-C7 Corvette.

Art responded straightaway.


"I replaced my C6 radiator when I was adding the supercharger. I blew it out from the back with compressed air. The only thing I am really sure about is: **do not ever use** a pressure washer on the radiator fins. It will bend, flatten and break the fragile fins."

"To prevent leaves and dust clogging things up, you could add a screen in front of the radiator, although it will slightly reduce air flow. For a base C6, which does not have the NACA duct in the nose, I think that the engine compartment can benefit from an additional air exit point. That's why I added a hood duct on mine. But I can't really quantify if it is helping or not."

I totally agree with Art's response. **Absolutely no pressure washer or steam cleaner.** Compressed air or a garden hose with a spray nozzle works the best. I would only add to not limit your inspection to the radiator fins.

Here is a clip from Hib Halverson that he authored for the 2024 National Corvette Southwest Caravan E-news on how Caravan participants might prep for the trek. Hib is a frequent contributor to Corvette Magazine.

"On C4, C5 and C6, there is a space between the A/C condenser and the radiator. Since those cars are mainly



Whether, you take on this project or not, I strongly suggest you add some Water Wetter to your surge/radiator tank. This was also recommended to folks traveling to the Museum during the Caravan and it works! Half a bottle added to our surge tanks dropped the operating temps during the long hot desert pull into Vegas by as much as 10 degrees. You can find it on Amazon or at most auto parts stores.

Don't get carried away. Follow the instruction on the bottle. While I don't believe in a "mechanic in a bottle", this stuff really works.

John completed his task and gave this summary.

Russ, a follow up on the email regarding the radiator cleaning on my C6 Corvette.

I ordered the 2-piece cleaning wand set and am very pleased with it. You get 2 "wands" which are sprayers on about a 15" tube that is angled at the end and has a spray tip. One is a water sprayer and one is an air sprayer. I think they are exactly the same except for an air chuck adapter screwed into the garden hose female fitting. Anyway, they work well and I really don't know how you could do a good job at this cleaning without it. There are many companies selling them online. I'd be happy to send pictures of mine if anyone is interested. I think the set was about \$40. I would loan mine out to a wellqualified person with a sizeable deposit! The hardest part of the whole operation and the most time consuming was the disassembly and re-assembly of the air cleaner/radiator cover! You have to take it all apart to access the radiator and AC condenser so you can blow them out. Oh, almost forgot, there is at least one YouTube video on this subject and I strongly suggest watching it before you attempt this project. There are also videos on changing coolant and improving cooling if you think you're getting too hot. There was quite a bit of debris of all kinds in the radiator, but not as much as I had thought after looking up from underneath. It did need a cleaning, though. I would think that the performance models would be even more critical than my LS-2 because this debris does affect the cooling ability to some degree. This job is not terribly difficult and I would think could be done by most "Corvette guys". No special tools except the cleaning wands, and it doesn't need to be on a lift. Can be done on the ground. Couple of hours, probably.

Good Luck, and feel free to forward this to anyone or follow up with something in Tech Talk.

With a little looking on the internet, I found these which should be similar to the ones that John used. I expect several other vendors have something similar but I found this

You could always make your own as Art did years ago when he needed to clean his tractor's radiator which was about




every time he used it. Art professes, "Clean radiator, clean mind." At least that's how he remembered it.

Let me start out with these lyrics from Roger's and Hammerstein's Broadway musical, *Camelot*.

It's May! It's May!
The lusty month of May!
That lovely month when ev'ryone goes
Blissfully astray.
Tra la! It's here!
That shocking time of year
When tons of wicked little thoughts
Merrily appear!

Well, I'm not sure that's still true, but welcome to May, when the sun shines more often than not, when the days grow warmer and longer, and life just seems a little better. It's time to wash and wax the Corvette and embrace spontaneity. Take your significant other out to the garage to see your new, shining Vette and then whisk her or him off to someplace new, or at least seldom visited. That's what May is all about, wicked little thoughts.

On a less happy note, while it seems that that the ultimate impact of the new 25% tariffs on all imports is as yet unknown, it struck me that Corvette might be one of the thousands of products that will be affected negatively by their imposition. 31% of the parts in a C8 Stingray are imported (mostly from Canada and Mexico) while 32% of parts for the E-Ray and Z07 are imported from the same sources. The 8-speed automatic transmission on the base C8 is made in Canada and shipped to Bowling Green. The same transmissions for the E-Ray and Z06 though using exactly the same architecture are not produced in Canada.

Using guesswork and rudimentary arithmetic all of this would mean that the base price of a C8 with the cheapest 1LT trim would rise by about \$4,000. The increase for the more typically outfitted C8 Stingray would climb accordingly. Ditto for the E-Ray and Z06. At the moment Canada seems willing to work out a compromise that would either eliminate the tariff or reduce it to, say, 10%. Mexico, on the other hand, has become the "bad boy" in this view of the world and consequently might find its exports to the U.S. tagged with that 25%-plus number the President seems so enamored of. Whatever the case, Econ 101 teaches us that tariffs ultimately present themselves as taxes on the citizens of the tariff imposing state, which in this case is us!

As an extension of the above, tariffs may also impact the at the pump price of gasoline in California. It is difficult to get current numbers from any of the State's multiple agencies that have their finger in the refined gasoline pie, but it would appear that as much as 70% of the crude processed in California refineries comes from abroad, and though I couldn't find any information on how petroleum imports are treated under the new tariff regime, let's assume that they will have a 25% tariff. As we all know from painful experience, in the gasoline business costs are passed on to the consumer, and if that model holds we should expect to see a rise in the cost of gasoline that could push it to \$6/gallon for regular, and we all know that our little darlings only drink the good stuff. So, keep smiling as you pump that precious liquid into the tank, it's worth it for a Corvette. Oh, to finish this with a bang, word is that two more of California's eleven refineries are about to close, killed off by the regulatory state and its war on internal combustion engines. If that happens, \$6/gallon may be a longed for memory.

On a brighter note, the April run to the Vintage Cowboy Winery was blessed with near perfect weather. Nineteen Corvettes motored out of the Santa Margarita Park & Ride lot just off of Hwy 101 for Pozo and the Winery. The hills I'm delighted to say were still green and as a consequence the drive was even more beautiful than usual. On behalf of Denise and myself we'd like to say "Thank You" to those of you who joined us and hope we can do it again next year.

Corvettes of Bakersfield is planning a large event for May 31. For those who sign up, the COB program will include a pre-event lunch, a caravan to the Raceway, a Corvette cruise-in and show, a Corvettes parade lap on the track, dedicated parking, free admission to the race, special seating for the race, and pit access. Meet-up locations are being arranged for SLO Vettes participants at a donut shop in Paso Robles and at Highway 58. SLO Vettes participants can look forward to a drive over backroads to Bakersfield.
